Governor Abbott Appoints Four to Board of Nursing

On February 1, 2021, Governor Greg Abbott announced the reappointment of three members to the Texas Board of Nursing (Board) as well as the appointment of one new member. Allison Edwards, DrPH, MS, RN, CNE, current Vice-President of the Board, who represents Baccalaureate Nursing Education, was reappointed and will continue to serve as Vice-President. Kathy Leader-Horn, LVN, who represents LVN Practice, and David E. Saucedo, II, who represents Consumers, were also reappointed to the Board. Dr. Edwards, Ms. Leader-Horn, and Mr. Saucedo's terms will expire on January 31, 2027.

Daryl Chambers of Grand Prairie was appointed to represent *Consumers* on the Board. He currently works as a senior analyst and accountant at Sixth Street and previously served as a senior operations analyst with Crestline Investors and is a member of the National Association of Black Accountants. Mr. Chambers received a Bachelor of Business Administration in Finance and Accounting from Texas Christian University. Mr. Chambers replaces Francis Stokes, who served on the Board from July 2015 to January 2021. Mr. Chambers' term on the Board will expire on January 31, 2027.

Between April 23, 2020, and October 2, 2020, Stephanie Lynn Baugh, remained employed as a registered nurse (RN) with a home health agency in Clute, Texas, after her license had been revoked by the Board. Stephanie Lynn Baugh continued to practice as a RN and provided skilled nursing care to patients at facilities and in their homes. The revoked status of the license was detected by the home health agency staff through a routine license renewal verification. According to the Board's licensure records, the license of Stephanie Lynn Baugh to practice nursing in the State of Texas was revoked on April 23, 2020. The case has been referred to the Brazoria County District Attorney for prosecution.

SYDNEY MICHELLE GOLDEN

a.k.a. Sydney Golden; a.k.a. Sydney M Golden; a.k.a. Sydney Michelle Smith; a.k.a. Sydney Serow; a.k.a. Sydney Michelle Serow Golden

On or about August 24, 2020, through October 5, 2020, Sydney Michelle Golden secured employment and practiced as a licensed registered nurse (RN) with a school district in Harris County, Texas, by using the license number belonging to another nurse with a similar name. Sydney Michelle Golden performed assessments, administered medications, and represented herself as a RN to staff, students, their families, and the general public while using the credentials of "RN" on facility business and medical records. The Board's

investigation revealed that the date of birth, social security number, ID photo, and address information provided by Sydney Michelle Golden to the employer did not belong to any nurse having a license or privilege to practice nursing in the State of Texas. The case has been referred to the Office of the Harris County District Attorney for prosecution.

Summary of Actions

A regular meeting of the Board of Nursing was held January 21, 2021, in Austin. The following is a summary of Board actions taken during this meeting.



In the January 22, 2021, edition of the *Texas Register*:

The Texas Board of Nursing (BON or Board) adopted amendments to §217.7, relating to Change of Name and/or Address, without changes as published in the December 4, 2020, issue of the Texas Register. On June 15, 2020, the Board launched the Texas Nurse Portal. The Texas Nurse Portal (Portal) is a paperless, online system that allows individuals to apply for nurse licensure by examination, endorsement, or renewal. In an effort to continue moving the Board's work flow to a paperless system, the adopted amendments require all name and address changes to be made online through the Portal. Amendments to §217.7 were effective January 27, 2021.

In the **February 12, 2021**, edition of the *Texas Register*:

The BON adopted amendments to §211.6, relating to Committees of the Board, without changes as published in the December 18, 2020, issue of the Texas Register. Under the Board's current rules, a quorum of the thirteen-member Board is required to convene in order to deliberate and vote on the adoption of emergency rules. Coordinating the appearance of a quorum of the Board on short notice can cause delay in situations that require flexibility, fluidity, and a rapid response. The adopted amendments authorize the Eligibility and Disciplinary Committee (Committee) of the Board to convene and consider and approve the adoption of emergency rules. The Committee is a standing committee comprised of three members of the Board, one consumer member and two nurse members. Amendments to §211.6 were effective February 16, 2021.

The Board also adopted amendments to §213.1, relating to *Definitions*, without changes as published in the December 18, 2020, issue of the *Texas Register*. Adopted amendments to §213.1 make non-substantive changes to the section in order to update outdated references to the Texas Board of Nurse Examiners. Amendments to §213.1 were effective February 15, 2021.

Amendments were also made to §213.20, relating to *Informal Proceedings and Alternative Dispute Resolution (ADR)*, without changes as published in the December 18, 2020, issue of the *Texas Register*. Adopted amendments to §213.20 were necessary to correct outdated references to the Board of Nurse Examiners within the text of the rule. Amendments to §213.20 were effective February 16, 2021.

The Board also adopted amendments to §215.2, relating to Definitions, without changes as published in the December 18, 2020, issue of the Texas Register. Minimum examination pass rates are required for a nursing education program's continued approval status. Examination pass rates are determined based upon a program's examination year. The current examination year for Texas professional nursing education programs is October 1 - September 30. This is a different time period than the examination year for Texas vocational nursing education programs, which is based on the calendar year (January 1 - December 31). The adopted rule amendments align the professional nursing education program exam year with the vocational nursing education program exam year, as well as with the exam year utilized by most accreditors and other boards of nursing. Amendments to §215.2 were effective February 15, 2021.

Amendments were also made to §217.23, relating to Balance Billing Dispute Resolution, with changes as published in the November 27, 2020, issue of the Texas Register. Amendments implement new requirements of the Insurance Code §§1271.157, 1271.158, 1301.164, 1301.165, 1551.229, 1551.230, 1575.172, 1575.173, 1579.110, 1579.111 and the Insurance Code Chapter 1467, effectuated by the passage of Senate Bill (SB) 1264 during the 86th Legislative Session, effective September 1, 2019. In order to protect consumers, SB 1264 prohibits balance billing by many out of network providers, except in a narrow set of circumstances. Additionally, SB 1264 authorizes a new dispute resolution process for claim disputes between out of network providers and health benefit plan issuers and administrators. Amendments to §217.23 were effective February 15, 2021.

The BON also adopted amendments to §222.4, relating to Minimum Standards for Prescribing or Ordering Drugs and Devices, without changes as published in the December 18, 2020, issue of the Texas Register. House Bill (HB) 2174, enacted during the 86th Legislative Session, requires prescriptions for controlled substances to be issued electronically after January 1, 2021, unless certain prescribed exceptions apply. One of the specified statutory exceptions provides for a waiver process. Pursuant to the Health & Safety Code §481.0755(a)(9) and §481.0756, a prescriber may issue a non-electronic prescription for a controlled substance if the prescriber has received a waiver from the prescriber's respective licensing agency. The waiver is valid for one year after issuance. A prescriber may re-apply for a subsequent waiver not earlier than 30 days prior to the expiration of the waiver, so long as circumstances that necessitated the waiver continue. The adopted amendments are necessary to implement the Board's waiver process under HB 2174. Amendments to §222.4 were effective February 16, 2021.

Amendments were also made to §223.1, concerning Fees, without changes as published in the December 18, 2020, issue of the Texas Register. On October 8, 2019, the Office of the Governor requested that occupational licensing agencies review their licensing rules and policies to identify areas where they could remove burdensome or unreasonable obstacles to licensure, specifically developing and implementing plans to reduce license application fees to 75% or less of the national average for equivalent or comparable occupations. In response, the Board reviewed the 2018 member profiles maintained by the National Council of State Boards of Nursing, which reports comprehensive, detailed fee information from responding boards of nursing. The profile revealed that the Board's current endorsement licensure fee is at 81% of the national fee average. Adopted amendments reduce the current endorsement fee from \$161 to \$125 meeting the Office of the Governor's request and maintaining legislative budget requirements. Amendments to §223.1 were effective February 15, 2021.

2021 Texas Board of Nursing Position Statement Updates

The Texas Board of Nursing (Board or BON) Position Statements are reviewed annually to determine if updates are required related to changes in national practice trends. Board staff keep apprised of changes in practice nationally through evidence-based practice developments, guidelines, and regulatory changes. Below is an overview of the six Position Statements in which changes were adopted by the Board at the January 21, 2021, Board Meeting, two of which with substantive changes.

Position Statements with non-substantive changes:

Position Statement 15.2, The Role of the Licensed Vocational Nurse in the Pronouncement of Death, includes non-substantive changes that reflect an update to the 2020 American Heart Association (AHA) Guidelines for Cardiopulmonary Resuscitation (CPR) and Emergency Cardiovascular Care (ECC). Board staff reviewed these new guidelines and the updated guidelines do not appear to change the substance of this Position Statement. however Board staff want to draw attention that this guideline has been updated.

Position Statement 15.8, *Role of the Nurse in Moderate Sedation*, has two non-substantive changes. The first is an updated link to the aforementioned 2020 AHA Guidelines for CPR and ECC. Again, Board staff does not believe this update changes the substance of this Position Statement, however Board staff want to draw attention that this guideline has been updated. The second change is an updated link to the new Position Statement released in 2020 by the Association of Women's Health, Obstetric, and Neonatal Nurses (AWHONN). Board staff does not believe the new AWHONN Position Statement impacts the substance of this Position Statement.

Position Statement 15.20, *Registered Nurses in the Management of an Unwitnessed Arrest in a Resident in a Long Term Care Facility,* includes non-substantive changes to provide consistency, clarity, and, as previously mentioned, update the hyperlink to the new 2020 AHA Guidelines for CPR and ECC. Again, these new guidelines do not change the substance of this Position Statement.

Position Statement 15.29, *Professional Boundaries including Use of Social Media by Nurses*, has a change to update one of the resources to the Positon Statement. The previously noted resource from the American Nurses Association (ANA), 2017, was the Social Networking Privacy Toolkit. This resource has been updated with a new hyperlink to the ANA Social Media portion of their website.

Position Statements with substantive changes:

Position Statement 15.6, Board Rules Associated with Alleged Patient "Abandonment", has an update that would clarify changes to the Nursing Practice Act and Board Rules that occurred in the 86th Legislative Session in 2019. Legislative changes allowed for the oral invocation of Safe Harbor if the nurse has immediate patient care needs. Since this Position Statement includes mention of Safe Harbor invocation, Board staff want to clarify this section of the Position Statement to align with legislative updates.

Position Statement 15.7, The Role of LVNs & RNs in Management and/or Administration of Medications via Epidural or Intrathecal Catheter Routes, includes substantive changes that align with the new Position Statement released in 2020 by the AWHONN. The changes include a hyperlink to the new Position Statement from AWHONN and alignment with the positon that only qualified anesthesia providers should verify the correct catheter placement and registered nurses (RNs) who are not licensed anesthesia providers should monitor but not manage the delivery of analgesia and anesthesia by catheter techniques to pregnant women.

As a reminder, Board Position Statements do not have the force of law, but are a means of providing direction to nurses on issues of concern to the Board relevant to protection of the public. Board Position Statements can be accessed, along with an explanatory video of the 2021 Position Statement updates, on the BON website under the heading **Practice** then **BON Position Statements**.



Announcing: The 2021 DECs



An updated version of the *Differ*entiated Essential Competencies of Graduates of Texas Nursing Programs (DECs) was completed and approved by the Texas Board of Nursing (Board or BON) at the January 2021 Board Meeting. A report of the approved updates can be viewed on the Board's website at: https://www.bon. texas.gov/pdfs/board_meetings_ pdfs/2021/January/7-2.pdf. A final version of the updates will be posted on the BON website.

The process for the update began with a comprehensive review of current literature. research. BON documents, accreditation and practice standards, and newer versions of previous documents referenced in the 2010 version. The purpose of the search was to assure references to nursing practice were up-to-date and to identify new concepts to be included in the competencies. A BON team of education and practice consultants developed suggestions for revisions that were supported by current practice and referenced documents. A Board-appointed Work Group comprised of nursing practice and education stakeholders reviewed the suggested revisions and rationales, and provided their input based upon expertise in the field.

The Introduction within the DECs provides a historical background dating back to the first statewide competencies in 1993 and lists the guiding principles that have created an ageless document:

- The DECs are client-focused, rather than institution-focused.
- The DECs are NOT a list of tasks or skills.
- Competencies provide essential role responsibilities, knowledge, and clinical behaviors and judgments in broad terms.
- Programs retain the ability to develop and create curricula for their individual communities, level of education, and program outcomes while focusing on the DECs.
- The DECs are not all-inclusive of all nursing competencies, but list competencies necessary for the nursing program graduate to seek licensure and enter nursing practice.

The DECs provide a set of outcomes expected of nursing education programs to ensure that newly licensed nurses enter practice with a knowledge base and a set of skills, including decision-making abilities, for safe practice. As the practicing nurses gain experience and hone their skills, their competencies continue to grow as they move from novice to expert. The 25 core competencies common



to each level of prelicensure nursing education show progression across the levels based upon the educational preparation. Each core competency is further developed into sub-competencies and knowledge required for successful attainment of the sub-competencies labeled as behaviors and judgments.

Other documents associated with the DECs include descriptions of scope of practice, a glossary of terms specific to the DECs, the reference list, and suggestions for practice and education to implement the DECs.



Board Rule 217.10(b), *Display of Designations*, states that while interacting with the public in a nursing role, each licensed nurse shall wear a clearly legible insignia that:

- (A) displays the nurse's name, but the manner in which the name appears, in reference to use of first name and/or last name, is the nurse's preference in accordance with facility policy, if applicable; and
- (B) identifies the nurse as a registered nurse or vocational nurse

according to licensure.

Additionally, Board Rule **Board Rule 221.2(c)** states when providing care to patients, the APRN shall wear and provide clear identification that includes the current APRN designation and licensure title being utilized by the APRN.

With the recent increase in utilization of telenursing practices, Board staff would like to remind nurses that it is important to communicate to the public your name and your licensure level when interacting in a nursing role via technology. Though an insignia may not always be visible through the use of technology, it is important for patients to know the nurse's name (either by the nurse's preference or in accordance with facility policy, if applicable) and the nurse's level of licensure LVN, RN, or APRN.

E-Prescribing Waivers for Controlled Substances

House Bill (HB) 2174, enacted during the 86th Legislative Session (2019), *requires* prescriptions for controlled substances to be issued electronically after January 1, 2021, unless certain specified exceptions apply. Pursuant to the Texas Health & Safety Code **§481.0755**, a prescription for a controlled substance is not required to be issued electronically and may be issued in writing if the prescription is issued:

- (1) by a veterinarian;
- in circumstances in which electronic prescribing is not available due to temporary technological or electronic failure, as prescribed by board rule;
- (3) by a practitioner to be dispensed by a pharmacy located outside this state, as prescribed by board rule;
- (4) when the prescriber and dispenser are in the same location or under the same license;
- (5) in circumstances in which necessary elements are not supported by the most recently implemented national data standard that facilitates electronic prescribing;
- (6) for a drug for which the United States Food and Drug Administration requires additional information in the prescription that is not possible with electronic prescribing;

- (7) for a non-patient-specific prescription pursuant to a standing order, approved protocol for drug therapy, collaborative drug management, or comprehensive medication management, in response to a public health emergency or in other circumstances in which the practitioner may issue a non-patient-specific prescription;
- (8) for a drug under a research protocol;
- (9) by a practitioner who has received a waiver under Section 481.0756 from the requirement to use electronic prescribing;
- (10) under circumstances in which the practitioner has the present ability to submit an electronic prescription but reasonably determines that it would be impractical for the patient to obtain the drugs prescribed under the electronic prescription in a timely manner and that a delay would adversely impact the patient's medical condition; or

(11) before January 1, 2021.

Texas Health and Safety Code §481.0756, authorizes the Board to issue a waiver from the e-prescribing requirement under the following circumstances only: economic hardship, technological limitations not reasonably within the control of the prescriber, or other exceptional circumstances demonstrated by the prescriber. Waivers are not required in the other situations described in §481.0755 above and cannot be issued by the Board for these additional circumstances.

Advanced practice registered nurses (APRNs) who meet the requirements for exemption in §481.0756 and wish to request a waiver may do so through the Texas Nursing Portal at https://txbn.boardsofnursing.org/ txbn. Please note that APRNs will need to create accounts in the Texas Nursing Portal if they have not done so already. APRNs who already have an account should use their existing account to complete the application process. Once on the dashboard in the Portal, there will be a header at the bottom titled "Other Applications". Select the button titled "Apply" under the header for Other Applications. Please select the Request for Waiver—E-Prescribing for Controlled Substances. If additional information is required to support a request for waiver, this will be communicated to applicants via the Portal. Once the waiver is granted, APRNs and the public will be able to verify the issuance of the waiver via the License Verification Portal at https://txbn.boardsofnursing.org/licenselookup.

It is important to note that each prescriber must obtain his/her own waiver from the licensing agency. Waivers issued to the delegating physician by the Texas Medical Board do not extend to APRNs to whom the physician delegates prescriptive authority. Each prescriber must obtain his/her own waiver as required by the Texas Health and Safety Code.



Federal PREP Act and COVID-19 Vaccination Administration

The Public Readiness and Emergency Preparedness Act for Medical Countermeasures Against COVID-19 (the PREP Act) was amended, and effective on January 28, 2021, to expand the vaccination workforce by permitting registered nurses and licensed vocational nurses with recently expired licenses to administer COVID-19 vaccines in any jurisdiction in which the PREP Act applies.

The PREP Act is a federal law. As such, the Texas Board of Nursing (Board) is not involved in its administration. The following FAQs are intended as a resource to provide useful information to employers, nurses, and the public regarding the applicability of the PREP Act. I am a nurse with a retired/ (lapsed) delinquent/inactive license. Can I administer the COVID-19 vaccine? And if so, in what states?

According to the PREP Act, registered nurses and licensed vocational nurses whose licenses expired within the past <u>five</u> years are able to administer COVID-19 vaccines in **any** state, provided the following conditions are met:

1. The nurse held an active license within the past 5 years;

2. The nurse's license is currently in inactive, expired, or delinquent (lapsed) status;

3. The nurse's license was active

and in good standing prior to the date it went inactive, expired, or became delinquent (lapsed);

4. The nurse's license was not revoked; surrendered while under suspension, discipline, or investigation by a licensing authority; or surrendered following an arrest;

5. The nurse is not on the List of Excluded Individuals/Entities maintained by the Office of the Inspector General; and

6. The nurse must complete the Centers for Disease Control and Prevention COVID-19 Vaccine Training Modules (CDC Vaccine Training Modules) and be observed by a currently practicing healthcare professional adequately experienced in vaccination who can confirm the nurse's competency in the preparation and administration of the particular COVID-19 vaccine to be administered.

Is there training that I must complete to provide the vaccine? If so, do I need to send proof of completion to the Board?

A nurse must complete the Centers for Disease Control and Prevention COVID-19 Vaccine Training Modules (CDC Vaccine Training Modules) and be observed by a currently practicing healthcare professional adequately experienced in vaccination who can confirm the nurse's competency in the preparation and administration of the particular COVID-19 vaccine to be administered.

The Board DOES NOT require that a nurse's proof of competency be sent to the Board prior to administering the COVID-19 vaccine under the PREP Act. However, Board Staff suggests that a nurse keep a copy of his/her training or competency verification should any questions arise about his/her practice in this role.

I am an employer; how can I ensure that a nurse is able to provide COVID-19 vaccine administration, given the requirements of the PREP Act?

An employer may verify the history of a nursing license in **NURSYS** to ensure that a nurse had an active nursing license in good standing that was subsequently placed in retired, inactive, or delinquent (lapsed) status within the last five years.

If a nurse meets the requirements of the PREP Act, how does that affect the nurse's scope of practice?

The PREP Act does not expand a nurse's scope of practice beyond that of the nurse's previously held nursing license; rather, the PREP Act only permits the nurse to provide COVID-19 vaccination administration.

If I meet the terms of the PREP Act, would I be able to provide other nursing care outside of the administration of the COVID-19 vaccination pursuant to the PREP Act's requirements?

The PREP ACT is intended to permit COVID-19 vaccination administration and does not extend to general nursing practice. However, vaccination administration includes the ability of the nurse to monitor

Texas Nursing Summit Report Published

The report of the Texas Nursing Summit: *The Future of Nursing in Texas: Stakeholders Moving Towards Alignment* was published on December 30, 2020, and presented to the Board of Nursing at its January 2021 quarterly meeting.

Background and Executive Summary:

In 2019, through deliberative alignment strategies, the Texas Board of Nursing (TBON) and the Texas Organization for Nursing Leadership (TONL) joined together to convene a Summit designed to engage conversations between academia and practice to improve the readiness of new graduates to transition into practice. The result was the *Invitational Nursing Summit, The Future of Nursing in Texas: Stakeholders Moving Towards Alignment.*

The purpose of this statewide Summit hosted by the TBON and the TONL was to develop a coordinated approach to address gaps between and within academia and practice and optimize clinical learning experiences for the future of nursing in Texas. Stakeholders from various national and state nursing organizations were invited to nominate member participants.

Over 130 nurses from academia and practice settings across Texas attended the two-day Summit on February 24-25, 2020, engaging in open discussion and problem solving.

Board Staff would like to express appreciation for the leadership of the BON Education Task Force, Board Liaisons: Dr. Allison P. Edwards, DrPH, MS, RN, CNE, and Laura Disque, MSN, CGRN, and the Summit Co-Chairs: Dr. Patricia S. Yoder-Wise, RN, EdD, NEA-BC, ANEF, FAONL, FAAN, and Dr. Paula J.Webb, DNP, RN, NEA-BC, FAONL, in seeing this work through to completion. Board Staff would also like to acknowledge the significant contributions of Dr. Leslie Norman, DNP, RN, NEA-BC, FACHE, and Dr. Brandy Wells, DNP, APRN, NNP-BC, in completing the analysis of the Summit findings presented in the report that formed the basis for the recommendations. Finally, Board Staff would like to thank Dr. Beth Ulrich, EdD, RN, FACHE, FAONL, FAAN, for writing and editing the final Summit report.

Resilience: Powered by Care and Caring

A historic winter storm hit the state with bitter cold, heavy snow, and ice. Power grid failures caused millions of residents to lose electricity for days. Every county in the state was affected: losing heat, light, communications – phone, internet, and TV, as well as access to food and water. Health care facilities faced external as well as internal disaster. Without power, essential medical services were halted in clinics. Durable medical equipment was lost in homes. While most hospitals were on power grids supporting electricity, utility providers were not - affecting hospital communications as well as the use of water. The financial costs and resulting morbidity and mortality related to the power outages is yet unknown.

Many citizens had needs never met during the disaster. Amazingly though, unprecedented assistance with environmental necessities came from the community, by caring families, neighbors, churches, and local businesses with very limited resources. Nurses, however, offered support unique to care providers who are face-to-face and heart-to-heart with patients suffering unexpected emotional and physical loss.

Recognized for being at the front line of health care, the role of the

and assess patients for any side effects or complications of the vaccine. Therefore, it would be expected that a nurse would monitor, assess, and intervene as necessary should a patient need to be stabilized after the vaccine administration.

I am a nurse who is <u>currently</u> licensed in Texas. Where can I provide COVID-19 vaccinations?

Currently licensed nurses may provide COVID-19 vaccination administration in **any** state or jurisdiction where the PREP Act applies. However, this authority is limited to COVID-19 vaccine administration and does not expand the nurse's scope of practice or extend to general nursing practice.


Texas Peer Assistance Program for Nurses (TPAPN): Help Another Nurse by Being a Peer Support Partner

A peer support partner is a fundamental part of the Texas Peer Assistance Program for Nurses (TPAPN). TPA-PN safeguards patients by providing early identification, support, monitoring, accountability, and advocacy to Texas nurses who have an identified substance use or mental health condition or related incident, so they may practice nursing safely. The peer support partner is a volunteer who provides support, guidance, encouragement, and more to TPAPN participants on their recovery journey.

To learn more about TPAPN or peer support partners, please visit the TPAPN website: **www.tpapn.org**. TPAPN is currently offering information sessions so you can learn more about the peer support partner role and see if this is for you! The next informational sessions are scheduled for April 20, 2021, and May 18, 2021, at 2 PM. Attendance is not required at an information session prior to becoming a peer support partner.

In order to become a peer support partner, attendance is required at a Peer Support Partner Workshop and then attendance is required every two years. The Peer Support Partner Workshop includes an overview of TPAPN, principles of peer support, and training on motivational interviewing. Once becoming a peer support partner, additional resources are available through TPAPN.

If you are ready to help another nurse, an application form is accessible on the TPAPN website (fill out and submit to TPAPN). The application includes responsibilities and guidelines for the peer support partner, including the requirement to attend the TPAPN Peer Support Partner Workshop. The next workshop will be held virtually on May 21, 2021. Registration will be on the TPAPN website, **www.tpapn.org**, prior to the date of the workshop.

Guam Becomes First US Territory to Enact Nurse Licensure Compact (NLC)

Gov. Lourdes "Lou" Leon Guerrero signed the NLC into law on March 5, 2021, making Guam the first U.S. territory to enact the NLC. The compact allows registered nurses (RNs) and licensed practical/vocational nurses (LPN/ VNs) to have one multistate license, with the ability to practice in person or via telehealth, in both their home territory/state and other NLC states. There are currently 35 states that have enacted the NLC.

Guam's entry into the NLC will enable nurses holding an active, unencumbered multistate license to practice in Guam to assist with the nursing shortage. Residents of Guam will not be able to obtain a multistate license until the NLC is fully implemented in 2022.

Primary sponsor of the bill and long-time champion of the NLC, Sen. Mary Camacho Torres, commented, "Today, Guam joins a growing number of states stepping into the future of nurse licensure. With the enactment of the NLC, nurses from other member states can now come here and practice immediately, increasing our people's access to safe, quality care without the need to apply and wait for a Guam nursing license or disaster declaration."

Licensing standards are aligned in NLC states, so all nurses applying for a multistate license are required to meet the same standards, including a federal and state criminal background check that will be conducted for all applicants for multistate licensure.

Updated Prescriptive Authority for APRNs Online Course

Texas Board of Nursing (Board or BON) staff have recently updated the online course *Prescriptive Authority for Advanced Practice Registered Nurses (APRNs)* available within the **CNE course catalog** on the Board's website. Registration for the course costs \$25. This online course provides information on the current laws and regulations governing prescriptive authority in the State of Texas. The course is designed to help the learner develop a greater understanding of delegation of prescriptive authority to Texas APRNs and requirements that must be met for APRNs to be in compliance with Texas laws and BON rules. The course has been approved for 1.2 contact hours of Continuing Nursing Education which can be used towards the five hours of pharmacotherapeutics content required for APRNs renewing prescriptive authority.

BON Continuing Competency Offerings Address Nursing Jurisprudence and Ethics Requirement




