

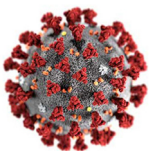


A Call to Education Programs to Assist with the COVID-19 Vaccination Effort

As vaccines arrive in our state to combat the devastating effects of COVID-19, schools of nursing are well-positioned to assist with this effort. While securing clinical learning experiences for students has been extremely challenging recently, the need for skilled and safe vaccine administration to large numbers of Texans presents an opportunity. To seize this opportunity, the Board of Nursing highly encourages that Practice-Academic Partnerships be created so that nursing students enrolled in a clinical nursing course who have been taught the principles of safe COVID-19 vaccine administration may do so under the supervision of faculty or a registered nurse who is serving as a preceptor for a school of nursing.

Allison Porter-Edwards Elected Vice-President of Texas Board of Nursing at October 2020 Board Meeting

Allison Porter-Edwards, DrPH, MS, RN, CNE, of Bellaire, was elected Vice President of the Texas Board of Nursing at the October 22, 2020 quarterly meeting. Governor Greg Abbott appointed Dr. Edwards to the Board representing baccalaureate education in July 2015 to serve a term that expires on January 31, 2021. Dr. Edwards serves as one of the lead faculty for the bachelor of science Pacesetter program at the University of Texas Health Science Center at Houston (UTHealth) School of Nursing.



Dr. Edwards is an honors graduate of The University of Texas Medical Branch at Galveston and earned her Master's in Nursing Administration in 1992 at Texas Woman's University in Houston. She received her doctoral degree from The UTHealth School of Public Health in 2006.

In 2015, she achieved Certification for Nurse Educators (CNE) and is a member of the Developmental Disability Nursing Association and Sigma Theta Tau-Zeta Pi Chapter. In January 2017, Dr. Edwards was awarded the Joan and Stanford Alexander Endowment for Intellectual and Developmental Disabilities. In October 2020, she received a Hall of Fame award from the University of Texas Medical Branch.

Differentiated Essential Competencies of Graduates of Texas Nursing Programs Workgroup Meeting via Videoconference

On November 9, 2020, a virtual meeting of the Differentiated Essential Competencies of Graduates of Texas Nursing Programs (DECs) Workgroup was held. The workgroup is comprised of nursing education and practice stakeholders, representing 10 statewide organizations, who were formally appointed by the Texas Board of Nursing (Board) at the October 22, 2020, quarterly Board meeting. The purpose of the meeting was to offer a forum for the workgroup members to generate recommendations to update the DECs to assure inclusion of current practices, research, and advances in nursing.

Board Staff presented suggestions for revisions to the DECs 25 Core Competencies and the four nursing roles of the DECs: Member of the Profession, Provider of Patient-Centered Care, Patient Safety Advocate, and Member of the Health Care Team. New concepts and wording were considered to ensure the DECs reflect contemporary nursing education and practice. The workgroup discussed plans for distribution of the document with the goal of presenting the updated DECs at the January 2021 Board meeting.

Newly Approved Human Trafficking Training Courses

The Human Trafficking Prevention continuing education requirement created by House Bill (HB) 2059 took effect on September 1, 2020. All nurses involved in direct patient care must complete a human trafficking prevention course approved by the Executive Director of Texas Health and Human Services Commission (HHSC) before the end of every licensing period. Recently, HHSC approved additional courses to meet this requirement.

Although it is not a requirement for a course to be approved, several courses offer Continuing Nursing Education (CNE) contact hours and many are free. CNE awarded for completing an approved course may count towards the 20 contact hours of CNE required for all nurses. Additionally, APRNs may use Category I Continuing Medical Education contact hours from an approved course towards renewal. Please reference the list of approved trainings for course details.

Summary of Actions



A regular meeting of the Board of Nursing was held October 22, 2020, in Austin.
The following is a summary of Board actions taken during this meeting.

In the **November 27, 2020**, edition of the *Texas Register*:

The Texas Board of Nursing (BON or Board) proposed amendments to §217.23, concerning *Balance Billing Dispute Resolution*. The proposed amendments are necessary to implement changes to the Insurance Code, effectuated by the passage of Senate Bill (SB) 1264 during the 86th Legislative Session, effective September 1, 2019. In order to protect consumers, SB 1264 prohibits balance billing by many out of network providers, except in a narrow set of circumstances. Additionally, SB 1264 authorizes a new dispute resolution process for claim disputes between out of network providers and health benefit plan issuers and administrators. All public comments were due no later than December 28, 2020.

In the **December 4, 2020**, edition of the *Texas Register*:

The Board proposed amendments to §217.7, relating to *Change of Name and/or Address*. On June 15, 2020, the Board launched the Texas Nurse Portal. The Texas Nurse Portal is a paperless, online system that allows individuals to apply for nurse licensure by examination, endorsement, or renewal. In an effort to continue moving the Board's workflow to a paperless system, the proposed amendments require all name and address changes to be made online through the Texas Nurse Portal. All public comments are due no later than January 4, 2020.

In the **December 11, 2020**, edition of the *Texas Register*:

The BON published its notice to review the following chapters pursuant to its adopted Rule Review Plan:

Chapter 213. Practice and Procedure, §§213.1 -213.35

Chapter 216. Continuing Competency, §§216.1-216.11

Chapter 221. Advanced Practice Nurses, §§221.1 -221.17

In conducting its review, the Board will assess whether the reasons for originally adopting these chapters continue to exist. Each section of these chapters will be reviewed to determine whether it is obsolete, whether it reflects current legal and policy considerations and current procedures and practices of the Board, and whether it is in compliance with Chapter 2001 of the Government Code (Administrative Procedure Act). In addition to this Rule Review, the Board has separately proposed editorial amendments to 22 Tex. Admin. Code §213.1, relating to Definitions, and §213.20, relating to Informal Proceedings and Alternative Dispute Resolution (ADR). These proposed amendments will be published in the December 18, 2020, edition of the *Texas Register*.

Telehealth and Nursing Education: Remote Patient Monitoring Clinical Site Application

Telecommunication reaches out to the previously unreachable rural areas of our country (Darkins & Cary, 2000). Remote care, as pointed out in *The Future of Nursing*, a report by the Institute of Medicine/Robert Wood Johnson Foundation (Institute of Medicine, 2011), predicted that shifts in time and place of care have significant implications for nursing. This suggests that nursing may be delivered remotely, similar to electronic health records (EHRs), computer provider order entry (CPOE) systems, lab results, imaging systems, and pharmacies that are linked in the exchange networks (Institute of Medicine, 2011). There is a growing body of literature suggesting that connected health such as telecommunication technology including telehealth can make health care more efficient by electronically connecting clinicians to clinicians, patients to clinicians, and patients to other patients (ANA Enterprises, 2019). The purpose of this paper is to explore options for teaching nursing students about telehealth by proposing creation of a comprehensive clinical site environment based on remote patient monitoring (RPM).

Definition and Trends

Definitions

Telehealth is generally considered an “umbrella term” for several modalities of telehealth.

- Telehealth: the use of electronic information and telecommunications technologies to support and promote long-distance clinical health care, patient and professional health-related education, public health and health administration.
- Technologies include: videoconferencing, the internet, store-and-forward imaging, streaming media, and terrestrial and wireless communications (ANA Enterprise, 2018, para 1).

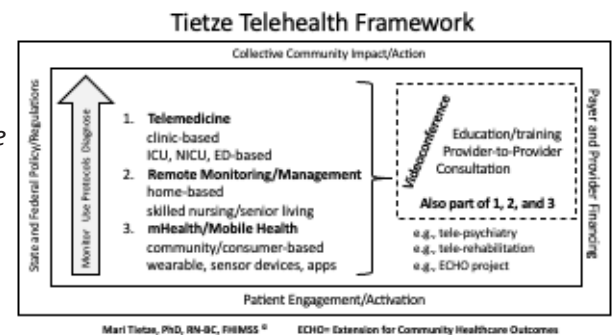
As such, telehealth applications include live synchronous videoconferencing, remote patient monitoring, and mobile health (ANA Enterprise, 2018).

Through the teaching of telehealth to nursing students and other allied health professions, for the past seven years, the authors noted that the students could ideally learn about telehealth when the modalities were clearly delineated. As such, one conceptual model, the *Tietze Telehealth Framework* was devised. By visually depicting the main telehealth modalities, the distinctions were clinically meaningful, and the curriculum content could be likewise organized.

For the purpose of this article, the term “telehealth” is intended to encompass three broad methods of digital care delivery that are “away” from the patient:

1. Telemedicine (stationary scheduled remote diagnostics of health status)
2. Remote management/monitoring/coaching (stationary home or facility-based, with scheduled and as-needed remote transmission of health status)
3. Mobile health (mHealth) “community” groups/social media (wearable mobile patient-generated health data with scheduled and as-needed remote transmission of health status) (Tietze & Brown, 2019). Figure 1 provides a schematic representation of these telehealth components, with the level 1 telemedicine being the diagnostic in nature, level 2 remote patient monitoring/management (RPM) being trend monitoring in nature, and level 3 mobile health being data collection in nature. Then, throughout all three methods of telehealth, videoconferencing is used, for example, for tele-psychiatry where additional peripheral equipment is not needed to provide the service (American Psychiatric Association, 2020).

Pandemic-Related Trends and Impact on Nursing Practice

With the advent of the coronavirus pandemic, telehealth has grown exponentially (KlasResearch.com, 2020). This growth was primarily fueled by an 1135 waiver emergency declaration of March 1, 2020 (Centers for Medicare and Medicaid Services, 2020). Via the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), which broadens the waiver authority under section 1135 of the Social Security Act, the Secretary had authorized additional telehealth waivers. As such, CMS waived the provider requirements for Medicare telehealth services from the distant site. The waiver of these requirements expands the types of health care professionals that can furnish distant site telehealth services to include all those that are eligible to bill Medicare for their professional services (Centers for Medicare and Medicaid Services, 2020).

Establishing Clinical Partnerships is Critical

Trends in patient care services will affect nursing practice, and as such, nursing education should be prepared to support the practice (ANA Enterprises, 2019). In terms of industry, however, nursing education should embrace the opportunity to partner with necessary service so that students may receive “real-world” experience. According to industry reports, for example, RPM services is in large demand and so are the associated clinicians (KLAS, 2019).

Teaching Telehealth to Nursing Students

When planning for nursing students' telehealth experiences, some things about clinical site management are the same, and others are very different (ANA Enterprises, 2019). For example, preparing the student for the clinical site characteristics and activities are similar but approach to preparation differs because the clinical site and the associated activities are remote.

The authors recognized three main components of the remote clinical site experience preparation: contractual agreement (A), instructors with locations (B and C), and clinical content with sequence (D). The relationship among those components must further be customized for the program level, the health condition, and the patient population characteristic. For example, the RPM clinical site experience should be customized for the bachelor's nursing student level, focused on the condition of heart failure management, and specific to the elderly population.

Contractual Agreement [Component A]

The typical Clinical Learning Agreement, or academic affiliation agreement, will contain dozens of components on behalf of the College of Nursing (CON), the clinical site and/or both. Some of the key agreement components are:

- Recitals
- Responsibilities of the nursing program
- Responsibilities of Other
- Mutual Responsibilities
- Term and Terminations
- EHR Product Restrictions
- Customer Consent
- Clinical Monitoring Services
- Privacy Terms and Conditions
- Health Insurance Portability and Accountability Act (HIPAA)

The *Clinical Site Schedule* is also important to determine on behalf of both the CON and the clinical sites. There will likely be limits for both parties and so determining the mutually allotted time requires advanced planning. In addition to the instructors' scheduling, the patient who will be involved with the clinical experience must also be determined ahead of time.

Instructors with Locations [Component B and C]

Instructors, or preceptors, from the RPM clinical site organization are considered the clinical expert for the clinical site experience. There are two instructors from the CON, one who is knowledgeable in telehealth and RPM and one who is knowledgeable in the course track content. Faculty and students may be operating from home, campus, or a clinical site equipped with RPM technology. The software programs and technical interfaces required for documentation of the clinical site activities must also be identified and reflected in the agreement.

Role of All Nurses in Telehealth

Although this article addressed the practice of the BSN and graduate level students in telehealth, nursing roles for the associate degree nurse and the vocational nurse also exist. For example, RPM tends to be driven by protocols and it also tends to be interprofessional in nature (KLASresearch.com, 2019). In the current state of the industry, the providers of these services identify the specifics of the roles for each member of the team. Much of the role specifics is based on the customer need. Again, this emphasizes the importance of the relationship and/or partnership between academia and the industry supplier of these services. Commonly the vocational nurse is important for the screening of the patient as they prepare for the RPM visit. The medication reconciliation process, for example, is key to the success of the RPM visit. Similarly, the associate degree nurse's role can be driven by the protocols used in a given RPM service organization.

Practice Questions and Answer

SAFE HARBOR: THE WHO, WHAT, WHEN, WHERE, AND HOW

Whether you're a newly licensed nurse, a seasoned nurse, or are new to nursing practice in the State of Texas, the Texas Board of Nursing (BON or Board) encourages **all** nurses to become informed about the Safe Harbor Nursing Peer Review (SHNPR) process. Questions that have emerged in relation to safe harbor during the current state of disaster are included in this practice Q&A along with general SHNPR questions and various resources linked via QR code to the BON website.

Q: What is safe harbor?

Safe harbor is a nursing peer review process that any licensed vocational nurse (LVN), registered nurse (RN), and/or advanced practice registered nurse (APRN) may initiate when asked to engage in an assignment or conduct that the nurse(s) believes in **good faith** would potentially result in a violation of the nurse's duty to a patient or be a violation of the Nursing Practice Act (NPA) or Board rules [NPR Law 303.005; and Board Rule 217.20(a)(15)].

Q: Who can invoke safe harbor?

Nurses, LVNs, RNs, and APRNs, who are employed by an organization that is required by Nursing Peer Review (NPR) Law (discussed further in the next question) to establish a nursing peer review committee may choose to invoke safe harbor if requested to engage in conduct that the nurse(s) believes

violates a nurse's duty to a patient [NPR Law 303.005; and Board Rule 217.20(a)(15)].

Q: Who is required to have a nursing peer review committee?

A person must establish a nursing peer review committee to conduct nursing peer review in accordance with NPR Law (Chapter 303 of the *Texas Occupations Code*) and the NPA (Chapter 301 of the *Texas Occupations Code*):

- for LVNs: if the person regularly employs, hires, or contracts for the services of eight (8) or more nurses; and
- for RNs or APRNs: if the person regularly employs, hires, or contracts for the services of eight (8) or more nurses, at least four (4) of whom are RNs. APRNs hold RN licensure and are counted in the total number of RNs.

Did you know? A person required to establish a nursing peer review committee under this section may contract with another entity to conduct the nursing peer review for the person.

Q: What if a nurse chooses to invoke safe harbor during a state of disaster declaration (i.e., pandemic)?

Safe harbor protections for the nurse remain the same during a state of disaster and/or pandemic; thus, a person required to have a nursing peer review committee cannot deny a nurse the right to invoke safe harbor. Currently, no waivers or rule changes have occurred to **Board Rule 217.20** and Chapter **303** of the *Texas Occupations Code* (NPR Law) as a result of the current pandemic. Board staff recommend nurses frequently check the BON website for the latest updates related to the COVID-19 state of disaster.

Q: Can a nursing peer review committee meet virtually during a state of disaster?

There is nothing in the NPA or Board Rules that prohibits a nursing peer review committee from meeting virtually. The nursing peer review committee would need to ensure it can satisfy the requirements of confidentiality and due process found in the NPA and Board's Rules as well as fulfill the requirements of their own nursing peer review policies in order to conduct SHNPR virtually.

Q: When I consider invoking safe harbor, is there a difference between accepting the assignment and refusing the assignment?

The BON urges each nurse to consider his/her duty to the patient(s) as the highest priority in making any determination to accept or refuse an assignment or requested conduct. The nurse's ability to invoke safe harbor protections and his/her right to have a nursing peer review committee evaluate the requested assignment remain the same whether the nurse accepts or refuses the assignment.

Accepting the Assignment

In situations when nurse(s) feel their duty to a patient may be violated, safe harbor can assist by allowing the nurse(s) to accept an assignment without fear of Board disciplinary action as they try to deliver the best care possible to the patient(s).

Patients are better off with the nurse accepting the assignment and providing care to the best of his/her ability than without the nurse providing any care at all in the vast majority of cases.

Refusing the Assignment

Board Rule 217.20(g) clarifies that a nurse should invoke safe harbor and refuse the assignment or requested conduct, pending a Safe Harbor Nursing Peer Review determination, if the requested assignment or conduct is one that:

1. Constitutes a criminal act;
2. Constitutes unprofessional conduct;
3. The nurse lacks the basic knowledge, skills, and abilities to deliver nursing care that is safe and that meets minimum standards of care to such an extent that accepting the assignment would expose one or more patients to an unjustifiable risk of harm.

Q: What if I choose to invoke safe harbor and refuse an assignment because my supervisor requests I transition to an area of practice that varies significantly from my current area of practice during a state of disaster?

In situations where a nurse refuses to engage in certain conduct or a requested assignment because he/she believes it is beyond his/her basic knowledge, skills, and abilities (i.e., scope of practice), then **Board Rule 217.20(g)(2)** requires the nurse and supervisor to **collaborate** in an effort to identify an assignment that "is within the

nurse's scope and enhances the delivery of safe patient care." *Clear communication* between staff and supervisors is essential to arrive at solutions that best focus on patient care needs without compromising either patient safety or a nurse's license. The results of this collaborative effort must be documented in writing and maintained in nursing peer review records by the chair of the nursing peer review committee [Board Rule 217.20(g)(2)].

During a disaster, RNs or LVNs may be requested to transition to unfamiliar roles and/or patient care settings where the patient population differs greatly from the RNs' or LVNs' current or most recent area of nursing practice. These circumstances can be challenging for both the nurse and the employer. **Board Rule 217.11 Standards of Nursing Practice** requires that when assignments are made, both the nursing supervisor and staff nurse take into consideration client safety, as well as the educational preparation, knowledge, skills, and physical and emotional abilities of the individual licensed nurse to whom a given assignment is being made.

Did you know? There are additional considerations for APRNs who are asked to work in the role of an RN to assist in RN staffing during a disaster. All APRNs are first licensed as RNs, and they are required to maintain RN licensure in order to maintain advanced practice licensure; thus, APRNs are not prohibited from accepting

an assignment that is within the scope of practice of an RN [**Board Rule 221.12(2)**]. When the APRN is working in the RN role, scope of practice is **limited** to that of the RN and they may not cross over into APRN scope and engage in activities such as medical diagnosis and ordering or prescribing when practicing in the RN role. In addition, the RN who holds current licensure as an APRN will be held to the highest level of his/her education and competency.

Q: What happens if my supervisor is able to remedy the situation after our collaboration (such as giving me an assignment that is within my scope), do I have to withdraw my request for a nursing peer review committee evaluation?

Nurses have the option to sustain or withdraw the request for safe harbor nursing peer review after collaboration with the nursing supervisor. The requested conduct or assignment that prompted the safe harbor invocation can either be satisfactorily resolved (and no longer believed to be a violation of a nurse's duty to a patient) or remain unresolved (and still believed in good faith to be a violation of a nurse's duty to a patient). Even if a satisfactory solution and appropriate assignment is arranged as a result of the collaboration be-

tween the nurse and supervisor, the nurse who invoked safe harbor still has the option to proceed, or not to proceed, with the request for a nursing peer review committee determination of whether the requested conduct or assignment would have violated a nurse's duty to a patient.

Q: What if my employer has threatened to report me to the Board citing patient abandonment because I invoked safe harbor and refused an assignment during a state of disaster?

Anyone can report a nurse to the Board at any time for any reason (e.g., patient abandonment or a nursing supervisor who acts in bad faith by denying a nurse due process to invoke safe harbor). A determination of violation of the NPA and/or Board rules requires a complaint driven investigation by the Board. Remember, an employer required to have a nursing peer review committee cannot deny a nurse the right to invoke safe harbor if done in good faith.

During an emergency, including but not limited to disasters, nurses may have to choose between the duty to provide safe patient care and protecting the nurse's own health. These situations are challenging for nurses and their employers, therefore the Board recommends policies and procedures be developed to provide clear guidance and direction to nurses to ensure patients receive safe and effective care. In any disaster setting, the patients are almost always better off with the nurse than without the nurse.

Did you know? A nurse's duty to a patient is not defined by any single event such as clocking in or taking report. From a BON standpoint, the focus for disciplinary sanctions is on the *relationship*

and *responsibility* of the nurse to the patient, not to the employer or employment setting. There is a distinction between a nurse leaving an employment setting versus a nurse violating a duty to a patient through leaving an assignment.

Q: What if I feel like my work is hard enough already with a current state of disaster, and now my employer wants me to adhere to new policies and procedures; can I invoke safe harbor because I don't agree with these changes?

Safe harbor must be invoked in good faith which means that it must be requested honestly, with good intentions to protect the patient, and in consideration of the nurse's duty to the patient. In other words, the motive for requesting safe harbor cannot be predicated on a personality conflict, retaliation, or misrepresentation of facts. It must be grounded in truth, based upon the assessment of risk to the patient and possible violation of the duty of the nurse to promote patient safety.

Did you know? It's the nurse's responsibility to recognize the nurse's "Duty to the Patient." Nurses are educated and trained to assess signs and symptoms, minute changes in conditions and circumstances. These keen assessment skills help the nurse recognize when unsafe assignments

are made or when an assignment changes, creating an unsafe situation. To have appropriate grounds for invoking safe harbor, the nurse must believe in **good faith** that the requested conduct violates his/her duty to keep patients safe.

Q: How do I invoke safe harbor?

Invocation of Safe Harbor Protections, in accordance with Board Rule 217.20(d), must be done:

- ✓ At the time the nurse is requested to engage in the activity,
- ✓ Prior to engaging in the conduct or assignment, and
- ✓ The nurse must notify the supervisor making the assignment that the nurse is invoking safe harbor.

Did you know? Invoking safe harbor is not just for nurses providing direct patient care. Safe harbor can also be invoked by nurse administrators or nursing faculty.

Q: When I have completed my shift (after I invoked safe harbor and accepted the assignment), can I leave and come back on another day to finish the paperwork?

No. A detailed written account of the safe harbor request that meets the requirements of the **Comprehensive Written Request for Safe Harbor Nursing Peer Review** must

Quick Request Form

The nurse may use the BON Safe Harbor Quick Request Form or may use any other means of recording the initial request for safe harbor in writing with the minimum information required under Board Rule 217.20(d)(3).

Verbal Request

If a nurse is unable to complete a Safe Harbor Quick Request or other written form meeting the requirements for a Safe Harbor Quick Request due to immediate patient care needs, the nurse may orally invoke safe harbor by notifying the nurse's supervisor of the request [NPA sec 303.005(b-1)&(b-2)].

be completed **before** leaving the work setting at the end of the work period [Board Rule 217.20(d)(4)]. In addition, a nurse who chose to orally invoke safe harbor must also sign and attest to the **Safe Harbor Quick Request** documentation completed by the supervisor to whom the nurse verbally requested safe harbor.

Q: Where do I send my safe harbor request? Should I fax it to the BON?

Please **DO NOT** mail or fax your request for safe harbor to the Board. The BON does not conduct nursing peer review. SHNPR must be done through the nursing peer review committee at the facility or agency where the conduct was requested/assignment was made. The SHNPR forms provided by the BON are meant to be a helpful resource to ensure you include all of the necessary information in your request. You are not required to use the forms provided by the BON; however, your request (by the end of the day) must be written and include the information outlined in **Board Rule 217.20(d)**.

Q: What happens after the nurse(s) submits all the requirements of the safe harbor forms to his/her supervisor before the end of the work period?

The nurse's supervisor should promptly submit the Safe Harbor Quick Request and Comprehensive Written Request for SHNPR, along with the accompanying documents supplied by the nurse(s) invoking safe harbor, if any, to the safe harbor nursing peer review committee chair. The safe harbor nursing peer review committee (Committee) must complete its review and notify the chief nursing officer (CNO) or nurse administrator of its findings within 14 calendar days of when the nurse invoked safe harbor, NOT 14 calendar days from when the Committee received the safe harbor forms. Then, within 48 hours of receiving the Committee's determination, the CNO or nurse administrator must review the Committee's findings and notify the nurse(s) requesting safe harbor of both the committee's determination and whether the CNO believes in good faith that the committee's findings are correct or incorrect.

Q: When I invoked safe harbor, I was not provided due process. What can I do if my employer is not conducting their nursing peer review process according to the BON rules and regulations?

Board staff recommend a collegial conversation between the nurse and his/her chain of command as a reminder of the intent of safe harbor, to bring to light a patient safety issue. If such a conversation does not result in due process for the nurse and/or nursing peer review is not conducted according to the BON rules and regulations, the nurse has a few options related to reporting in order to ensure patient safety. Again, the focus of this reporting would be that attempts to remedy the patient safety issue within the facility have not occurred due to a failure to properly implement the nursing peer review process.

If the facility has a CNO or nurse administrator, Board Rule 217.20(j) (1) states that the CNO or nurse administrator of a facility, association, school, agency, or of any other setting that utilizes the services of nurses is responsible for knowing the requirements of the Board's Rules and for taking reasonable steps to assure that nursing peer review is implemented and conducted in compliance with the NPA and the NPR law. Therefore, the nurse could report the CNO or nurse administrator to the Board.

Additionally, if there is no CNO or nurse administrator, and the patient safety issue remains unresolved, a nurse should remember that under **NPA Section 301.402**, nurses are 'mandatory reporters' and shall report to the Board if the nurse has reasonable cause to suspect that another nurse has engaged in conduct subject to reporting. The nurse's duty to

comply with mandatory reporting requirements is a licensure-related function that is separate from that of an employer. The definition of conduct subject to reporting can be found in **NPA Section 301.401**.

Finally, if the facility itself is cause for the patient safety issue that remains unresolved, the NPA contains information related to the topic of reporting in **Subchapter I Reporting Violations and Patient Care Concerns**. Within this chapter, Sec. **301.4025** discusses an optional report by a nurse. If a nurse has reason to believe that a facility is failing to abide by the regulatory requirements applicable to that facility and is therefore jeopardizing patient safety, the nurse may make an optional written report to the appropriate licensing board or accrediting body as addressed by NPA Section **301.4025** (*Optional Report by Nurse*). It is important to note that in some instances, specific practice settings have requirements for the establishment of nursing peer review within the laws and rules of the practice setting. So this type of report could include a report of the safety issue in addition to a report surrounding the failure to establish nursing peer review. A nurse should also be aware of their whistleblower protections found in NPA Section 301.412 Retaliatory Action.

Did you know? Nursing professional organizations, such as the **Texas Nurses Association** can also offer additional information and advocacy related to protections for the nurse and the employment setting. While the Board cannot address employment issues, professional nursing organizations exist to serve

their members and may be able to provide nurses with additional guidance.

The BON continues to urge nurses to remain vigilant in protecting their patients and advocating for patient safety while welcoming collegial and collaborative communications with supervisors in order to find safe solutions for patient care. When safe harbor is invoked in good faith, the nurse essentially announces the potential risk to the patient and details where the conduct may violate the nurse's duty to the patient. The nurse is protected from disciplinary action and the conduct or assignment in question is provided review by the nursing peer review committee. The BON encourages **all** nurses to remember that the overall goal for safe harbor is to problem solve in the interest of patient safety.

Statistical Information

The 261 disciplinary actions reported in this bulletin represent only 0.058% of all nurses who are currently licensed to practice in the State of Texas. As of September 2020, 99.69% of currently licensed Registered Nurses and 99.62% of currently licensed Vocational Nurses were without discipline according to Board records.

Texas Peer Assistance Program for Nurses (TPAPN): Peer Support Partner Workshop

The Texas Peer Assistance Program for Nurses (TPAPN) provides support, monitoring, accountability, and earned advocacy to Texas nurses who have an identified substance use and/or mental health condition or related incident. Peer Support Partners are an essential part of TPAPN.

The Peer Support Partner is a nurse volunteer who provides peer support to nurses participating in TPAPN. Peer Support Partners meet or speak with their assigned participants on a regular basis and communicate regularly with their assigned participants' case managers.

Peer Support Partner training workshops are held regularly. The next Peer Support Partner workshop will be virtual and is scheduled for Friday, February 12, 2021. The registration information will be accessible on the TPAPN website prior to the event.

K-12 COVID-19 Testing Project in Texas Schools

In October 2020, the United States Health and Human Services Department, as part of the Nation's Coronavirus Testing Strategy, distributed 150 million Abbott BinaxNow rapid test kits across the nation. The Texas Division of Emergency Management (TDEM), in coordination with the Texas Education Agency (TEA), was directed to ensure the effective distribution of the test kits to Texas school systems.

Participating school systems are provided with the test kits, personal protective equipment (PPE), product training, and support to refill supplies. The rapid test kits are for the exclusive use and control of the school system. The policy and use of the kits are at the discretion of the school systems' administration.

School nurses may find themselves responsible for testing students and/

or staff in their schools. The Nursing Practice Act (NPA) describes a defined limit to nursing practice, as nursing practice "does not include acts of medical diagnosis or the prescription of therapeutic or corrective measures" [NPA Sec. **301.002(2)&(5)**]. Professional and vocational nursing requires the acts/procedures being performed be within the scope of that particular nurses' practice and appropriate orders be in place for acts that go beyond the practice of nursing. In order for the nurses in participating schools to use these test kits, appropriate physician delegation orders must be in place. Electronic Submission of APRN Application Supporting Documents

The APRN Department is pleased to announce that email submission of Verification of Completion (Part II) forms and electronic graduate level transcripts will be permitted on an ongoing basis. Staff encourages the electronic submission of documents via these mechanisms for more timely processing of applications. While forms submitted by mail will still be accepted, processing timeframes may be delayed for documents sent by postal mail.

VERIFICATION OF COMPLETION

(Part II): The form must be completed **in its entirety**. However, two exceptions to the requirements will be made when the form is submitted via email. The program director's electronic signature will be accepted in lieu of the requirement for an original signature. Additionally, an embossed school seal is not required when the document is submitted via email.

If the program chooses to submit the Part II via email, it must be submitted directly to aprn@bon.texas.gov from the program official's institutional email address. **Applicant submissions of the document will not be accepted. Likewise, forms submitted from a personal email account will not be accepted.** Please note, if authentication of the form cannot be confirmed, it is possible the APRN Department will reject the electronic version and require submission of the form via postal mail.

The exceptions outlined above only apply to the email submission of the Verification of Completion form. If the program chooses to mail an original hard copy to the Board's physical address, an original "wet" signature and school seal are still required.

TRANSCRIPTS: The APRN Department accepts electronic transcripts (e-transcripts) from the following sources:

National Student Clearinghouse, Parchment, eScrip-Safe, Credential Solutions, or official e-transcripts requested by the graduate and made directly accessible to the APRN Department via the school's registrar. Applicants should contact their academic institution for information regarding how to initiate this process. Board staff cannot request a transcript on an applicant's behalf.

E-transcripts must be sent to aprn@bon.texas.gov. Students are **not** permitted to submit personal copies (.pdfs) of transcripts. The transcript must be emailed directly from one of the sources listed above.

If transcripts are submitted via postal mail, original parchment documents are required. Photocopies of transcripts will not be accepted.

Updated Interactive Nursing Jurisprudence and Ethics Online Courses

The Board has recently launched two revamped online courses, the Texas Online Nursing Jurisprudence Exam Prep Course and the Interactive Online Course: Nursing Regulations for Safe Practice. These courses are set in a new interactive platform with updated information and resource links.

The Texas Online Nursing Jurisprudence Exam Prep Course offers an overview and interactive instructions on the subject areas covered in the exam. The course is delivered online with the ability to bookmark "Hot Topics" for a quick review. The course, complete with training on how to locate information for further review and printable resources that will aid study and practice questions, will be useful not only for exam preparation but for future nursing practice. This course is geared toward those seeking licensure in the State of Texas. This course **DOES NOT** meet the two (2.0) hour CNE requirement for nursing jurisprudence and ethics established during the 2013 Legislative Session.

The Interactive Online Course: Nursing Regulations for Safe Practice is intended to enhance the knowledge of Texas licensed nurses at all levels of licensure in the area of Texas nursing laws, rules, and regulations by addressing the Texas Nursing Practice Act, the Texas Board of Nursing (Board) Rules and Regulations, Board position statements, and other resources found on the Board's website in an effort to promote and protect the welfare of the citizens of Texas. This course **DOES** meet the two (2.0) hour CNE requirement for nursing jurisprudence and ethics established during the 2013 Legislative Session and offers a total of 2.8 approved CNE hours. This course cannot be used to fulfill the nursing jurisprudence and ethics stipulation that is required for all Board disciplinary orders.

Both courses cost \$25.00.

In addition, the Board offers Nursing Jurisprudence and Ethics workshops throughout the year. The workshop schedule and two new course offerings can be found on the Board's **CNE Course Catalog**.

Updated Prescriptive Authority for APRNs Online Course

Board staff have recently updated the online course *Prescriptive Authority for APRNs* available within the **CNE course catalog** on the Board's website. Registration for the course costs \$25. This online course provides information on the current laws and regulations governing prescriptive authority in the State of Texas. The course is designed to help the learner develop a greater understanding of delegation of prescriptive authority to Texas APRNs and requirements that must be met for APRNs to be in compliance with Texas laws and BON rules. The course has been approved for 1.2 contact hours of Continuing Nursing Education which can be used towards the five hours of pharmacotherapeutics content required for APRNs renewing prescriptive authority.

If questions arise during your registration or during an online learning course, there are specific Help links throughout the process to direct you to the dedicated Online Learning Help Desk.

Secure online payments are completed using major credit cards, bank cards (those with Visa or MasterCard logos), or online checks. Registration payments submitted directly to the Board will be returned and the registration process will be delayed. Employers, organizations, or groups can complete payment for multiple registrants with the purchase of a bulk voucher. The bulk voucher system will send the voucher information to the group coordinator for distribution to individual registrants. Each individual will use the voucher as the form of payment during her/his own online registration.

BON Continuing Competency Offerings Address Nursing Jurisprudence and Ethics Requirement

In 2013, the 83rd Regular Texas Legislative Session passed a law that specified continuing education requirements for all nurses. Senate Bill (SB) 1058 requires nurses to complete at least two hours of continuing education related to nursing jurisprudence and ethics before the end of every third two-year licensing period. The BON has two continuing education offerings which meet the requirement: the workshop titled, "Protecting Your Patients & Your Practice, Nursing Jurisprudence & Ethics", and the interactive online course titled, "Nursing Regulations for Safe Practice".
