

Allison Porter-Edwards Reelected Vice-President of Texas Board of Nursing at October 2024 Board Meeting

Allison Porter-Edwards DrPH, MS, RN, CNE, CDDN, FAAN, Associate Professor for Undergraduate Studies at the UTHealth Cizik School of Nursing has been elected to a third consecutive two-year term as Vice President for the Texas Board of Nursing (BON). She has served as clinical track faculty for over 15 years teaching clinical in Community/Public Health, and represents Baccalaureate Degree Nursing education (BSN) for the BON.

During her career at UTHealth Houston, Dr. Allison Porter-Edwards has taught eight of the 10 core courses in the RN-BSN program and has been the lead faculty in three Pacesetter BSN courses for senior nursing students, taught first semester nursing students lab for health assessment, and served as faculty mentor/preceptor for DNP student practicums.

Dr. Porter-Edwards has developed over 16 clinical affiliation agreements focused on the care of people with developmental, intellectual, acquired, and progressive disabilities. Her last six years at Cizik School of Nursing has been focused on conducting the ASK (attitudes, skills, and knowledge) and MOSAIC (mentoring our students to achieve interprofessional collaboration) fellowship funded by an endowment and a grant with the overarching goal of providing nursing students with improved attitudes, skills, and knowledge in the care of people with disabilities through experiential, clinically immersive experiences. She has published extensively on this topic.

In 2022, her fellowship was recipient of the Innovations in Professional Nursing Education for Academic Health Centers Award by the American Association of Colleges of Nursing. She is a University of Texas Medical Branch Hall of Fame recipient (2020) and Golisano Institute Fellow (2024).



A regular meeting of the Board of Nursing was held October 24, 2024, in Austin. The following is a summary of Board actions taken during this meeting.



In the November 29, 2024, edition of the *Texas Register*: The Board of Nursing (Board) adopted amendments to 22 Texas Administrative Code §211.7, relating to Executive Director, without changes to the proposed text published in the September 20, 2024, issue of the *Texas Register* (49 TexReg 7570).

The Board has established an agreed order to inactivate a nurse's license if it is found that their education is not substantially equivalent to a Texas approved nursing program's requirements. Traditionally, such orders have been ratified during a regular Board meeting or a meeting of the Board's Eligibility and Disciplinary Committee. However, certain agreed orders are currently accepted on behalf of the Board by the Executive Director. The adopted amendments aim to include inactivation orders, based on educational deficiencies, among those that the Executive Director can accept. This delegation of authority is intended to reduce the time between a nurse's agreement to inactivate their license and their removal from practice. The Executive Director will provide summaries of these actions at regular Board meetings. Additionally, the amendments clarify the Executive Director's authority to accept orders for nurses facing temporary suspension under the Occupations Code §§301.455 & 301.4551. These changes aim to improve regulatory efficiency by processing monitoring or suspension orders signed by Respondents without waiting for a temporary suspension hearing or other Board meeting.

The Board also adopted amendments to §213.33, relating to Factors Considered for Imposition of Penalties/ Sanctions, without changes to the proposed text as published in the September 20, 2024, issue of the Texas Register (49 TexReg 7571). On January 25, 2023, the U.S. Department of Health and Human Services Office of Inspector General (HHS-OIG) and law enforcement partners executed a coordinated, multi-state operation to apprehend individuals involved in selling fraudulent nursing degree diplomas and transcripts. The scheme allegedly involved the sale of fake nursing diplomas and transcripts from accredited Florida-based nursing schools to Registered Nurse (RN) and Licensed Practical/Vocational Nurse (LPN/VN) candidates. Those who obtained these fraudulent credentials used them to qualify for the national nursing board exam. Upon passing the exam, these individuals were eligible to obtain licensure in various states, including Texas, to practice as RNs or LVNs.

The Board has begun disciplinary actions to revoke or deny the renewal of licenses and to deny initial licenses to individuals implicated in the scheme. Additionally, the Board has begun to deny licensure or take action against other individuals who obtained legally insufficient education. According to Tex. Occ. Code §301.451, it is illegal to practice nursing with a diploma, license, or record obtained unlawfully or fraudulently. Tex. Occ. Code §301.452(b)(1) authorizes the Board to act on violations of Chapter 301 or any related rule, regulation, or order. The adopted amendments bridge the

gap between a violation of Tex. Occ. Code §301.451 and the concurrent violation of Tex. Occ. Code §301.452(b) (1).

The adopted amendments aim to clarify the Board's stance on these violations, informing licensees and the public about the likely sanctions for such violations based on the Disciplinary Matrix's Tier and Sanction Level analysis. The amendments also specify disciplinary actions for applicants who falsely certify that they meet Texas's licensure qualifications. A number of applicants for renewal and licensure have inaccurately claimed to meet educational requirements, leading to the licensure of nurses who have not completed the necessary clinical or didactic education, posing a significant public health risk. The amendments seek to ensure applicants understand the Board's position on this behavior and to maintain consistency in applying the Board's disciplinary matrix.

Additionally, the adopted amendments distinguish between technical and substantive requirements of a Board order. Current language misclassifies remedial education, typically required in Board disciplinary orders, as technical, non-remedial requirements. The amendments remove this language to align with the Board's current view of these violations.


Amended §211.7 and §213.33 became effective December 3, 2024.

Scammers Target Nurses Using Faxed Falsified Documents

Texas nurses, including advanced practice registered nurses, are being targeted by scammers seeking to extort money making false claims that the Board of Nursing (BON) has suspended the nurse's license(s). The scammers may contact the nurse by phone, make false claims involving controlled substance violations, and require the nurse to send money by wire transfer or other non-recoverable means to temporarily halt disciplinary action against the nurse while the investigation proceeds. Nurses are usually told not to discuss the case with anyone or risk further legal action.

Scammers may ask for a fax number to send fraudulent documents that contain vague allegations, along with other fraudulent documents from agencies such as the Federal Bureau of Investigation, the Drug Enforcement Agency, and/or the Department of Justice. The documents sent usually make it appear to be a joint investigation involving both state and federal agencies.

Fraudulent documents sent by scammers may include a graphic such as the BON Banner, a copy of an older BON logo, the nurse's National Provider Identifier (NPI) number, and fake signature(s).

Scammers often include the nurse's license number and NPI on the correspondence.

To clarify, the Board of Nursing will not:

- * include NPI numbers on correspondence relating to investigations,
- notify nurses about investigations by Fax. Notices are sent by certified mail to the nurse's address of record,
- * request that nurses send money to pause investigations, or
- * require the nurse to not discuss the investigation with anyone through some type of non-disclosure agreement.

Individuals attempting to deceive a nurse through such acts will try to envoke fear through isolation and fear of reporting. Any nurse who has received correspondence such as this or been contacted by an individual should:

1) Report the attempted fraud to the Office of the Inspector General (OIG) for the U.S. Department of Health and Human



- 3) Notify the Board of Nursing concerning the scam.

The BON routinely uses certified and regular mail to conduct investigations and always includes the name and contact information of the BON investigator, including the investigator's email address and direct dial phone number. Nurses should remain vigilant against scam techniques involving any of the techniques described above, save any correspondence that seems questionable, and report the attempted fraud as soon as possible.

There were a total of 220 nursing programs in Texas at the end of 2024. These included 87 vocational nursing (VN) programs, one diploma program, 68 associate degree nursing (ADN) programs, and 64 baccalaureate degree nursing (BSN) programs (including three alternate entry programs).

During Fiscal Year (FY) 2024, the Board of Nursing (BON or Board) approved nine proposals for new programs (four BSN, one ADN, two VN, and two Masters of Science in Nursing degree with Advanced Practice Registered Nurse role), while eight programs voluntarily closed (one BSN, three ADN, and four VN). The 2023 NCLEX examination reports for VN and RN test-takers revealed the results as seen in Table 1 below.

Even with the large number of new licensees to enter the workforce, Texas is still struggling to address the nursing shortage. Nurses work in various areas of healthcare but are leaving the practice as national data have shown (Smiley et al., 2023). Attention is being given to how healthcare facilities can provide a more supportive environment for nurses to practice safely.

When the Education Consultants make survey visits to nursing edu-

cation programs and ask individual students why they want to be nurses, most describe how a nurse influenced their lives with the care, skills, and support provided to them or their families.

Board Approves Michigan English Test (MET) for Internationally Educated Applicants

The Board has officially approved the Michigan English Test (MET) as an accepted measure of English proficiency for internationally educated nursing applicants seeking licensure through Texas. This update allows international candidates an additional pathway to demonstrate their language skills when applying for the NCLEX[®] exam.

Background on the MET and Standards

The MET's adoption as a standard aligns with established practices across various states, following the minimum score benchmarks set by the Health Resources and Services Administration (HRSA). To qualify, candidates must achieve an overall MET score of 55, with a minimum of 55 on the speaking section. This benchmark has been proven effective through a previous standard-setting exercise conducted by the National Council of State Boards of Nursing (NCSBN) and aligns with the standards used in the predecessor exam, the Michigan English Language Assessment Battery (MELAB).

Why This Matters

Under Rule §217.4(a), internationally educated nursing applicants must meet approved English proficiency standards unless their nursing education was conducted substantially in English. The addition of the MET provides a legally sound and evidence-based option, based on research from the NCSBN, to help streamline the licensure process for gualified international candidates.

What's Next

This decision means that applicants now have more choices in meeting Texas's English proficiency requirements, making licensure more accessible to diverse candidates. With this approval, Texas joins a growing list of states that recognize MET as a valid standard for English proficiency in healthcare.

Drug Compounding Considerations for Nurses



The Food and Drug Administration (FDA) considers drug compounding to be the act of combining, mixing, or altering ingredients to create a medication that is specific to an individual patient. Compounded drugs can help meet unique patient needs. For example, a drug may be compounded for a patient who cannot be treated with an FDA-approved medication, such as a patient who has an allergy to a certain dye and needs a medication to be made without it, or an elderly patient or a child who cannot swallow a tablet or capsule and needs a medicine in a liquid dosage form. Nurses may receive medication orders for drug combinations or dosages that are not commercially available as premade products. In some cases, nurses may be expected to act on these orders by preparing a compounded drug.

Unlike manufactured drugs that have gone through the FDA evaluation and approval process, compounded drugs are not FDA-approved and are therefore generally intended to meet the needs of a specific patient pursuant to a medical order from a practitioner. With an order or delegation, nurses may create compounded drugs consistent with their individual scope of practice for immediate use on-site. Nurses cannot distribute compounded drugs for use off-site. The Texas State Board of Pharmacy (TSBP) is the state agency responsible for establishing regulations for pharmacy practice and the licensing/registration of Texas pharmacists, pharmacy technicians, and pharmacies. For more information on the laws and rules that apply to the practice of pharmacy, including

the regulations that apply to pharmacies engaging in sterile or non-sterile compounding, it is recommended to contact TSBP directly.

The process of drug compounding can be influenced by a multitude of intrinsic and extrinsic factors to the nurse including training, human and material resources, equipment and supplies, and facility infrastructure. If such factors are of poor quality, then the likelihood of compounded drugs being contaminated or ineffective increases thus exposing patients to significant risk of adverse events. Identifying safety concerns and advocating for patients is critical to ensuring patient safety. Contaminated drug products compounded at medical offices and clinics that were prepared under unsanitary conditions has led to serious patient illnesses, hospitalization, and death. Examples of unsanitary conditions include but are not limited to: poor aseptic practices, using dirty equipment, and improper facility design to maintain appropriate levels of cleanliness.

Nurses who engage in drug compounding need to ensure a safe environment for their patients and must obtain the requisite knowledge and training necessary to create compounded drugs safely and competently. Prior to drug compounding, nurses should perform a self-evaluation to ensure that they have the appropriate education and training to perform the act, and currently possess the depth and breadth of knowledge necessary to do so safely and competently. The Board of Nursing (Board) expects that nurses practice in accordance with the current standard of care, best practices, and evidence-based practice findings/guidelines relevant to their practice area. The United States Pharmacopeia (USP) develops standards for preparing compounded drugs to help reduce risk for contamination, infection, or incorrect dosing. For example, USP General Chapter <797> (Pharmaceutical Compounding - Sterile Preparations) covers all facets of sterile compounding and is aimed at protecting patients. Nurses should know and conform to the national standards outlined by the USP relevant to their practice of drug compounding.

It is incumbent upon every nurse to seek appropriate information, support, and resources to inform their practice decisions. Drug compounding is a process requiring attention to detail and unique knowledge, training, and skill to perform. It is critical that any manipulation of medications, particularly those required to be sterile, occurs in accordance with conditions and practices designed to prevent contamination and other quality concerns. Patients can be significantly harmed when drugs are compounded in a way in which quality or sterility cannot be assured. New Publication on the Future of Nursing in Texas

On April 22-23, 2024, over 100 representatives from nursing education, nursing workforce, nursing practice, and state agencies attended the 2024 Nursing Summit - The Future of Nursing in Texas: Stakeholders Moving Toward Alignment in Austin, Texas. The purpose of the summit was to promote innovative opportunities to increase the quality of nursing education to produce competent nursing graduates who will transition into safe practice, all while embracing an evolving healthcare environment.


This 2024 Summit was the result of previous initiatives and recommendations among constituents and leaders to collaborate on issues in nursing. The Texas Board of Nursing (BON or Board), the Texas Nurses Association (TNA), and the Texas Organization for Nursing Leadership (TONL) collaborated throughout 2023 to plan the Summit designed to continue the working partnership between academia and practice to improve readiness of new graduates to transition to practice.

The 2024 Summit focused on three areas of nursing: education, practice, and workforce. Summit attendees listened to presentations, panel discussions, and broke into groups to discuss major topics affecting



nursing today. After the Summit, recordings of presentations and discussion notes were analyzed to identify four primary themes and develop recommendations to target the primary issues identified by participants.

Four Primary Themes in Summit Discussions



Synthesis of the discussions, themes, and issues from participants resulted in six identified focal areas of recommendations. The following demonstrates a *sample* of such recommendations.

Faculty Shortage: Nursing education programs identified that two main reasons that limit their enrolling more nursing students are: faculty shortages and a lack of clinical placements for students.

- Establish a mentoring program available to new faculty.
- Establish an online database of potential faculty for sharing among all nursing programs.
- Accommodate remote work practices for faculty to facilitate a work-life balance.

Clinical Placement for Students: Difficulties finding adequate sites for students affects adequate practice preparation for students at all levels.

- Participate with a collaborative, shared clinical placement group to maximize finding and agreeing on placements.
- Consider a model of assignments that includes other levels of students such as a Vocational Nursing (VN) and Registered Nursing (RN) student working together with patients.

Preparing Students to Successfully enter the Workplace:

- Incorporate nurse apprenticeship/partnering models to enrich the clinical experiences and facilitate the nursing students as contributing healthcare team members.
- Offer counseling on stress management, work-life balance, and study skills to decrease stress and anxiety related to nursing.
- Provide enhanced training and support for preceptors.

Transition to Practice for New Graduates: The transition from being a student in a nursing school to becoming a nurse caring for patients in a real practice setting is challenging for new graduates. There are often gaps between the theoretical basis of what a nurse learned in school and what is expected in their clinical practice setting.

- Implement new nurse residency programs that allow enhanced orientation.
- Create structured nurse mentoring programs.
- Establish a nurse residency program for Advanced Practice Registered Nurse (APRN) programs.

Nurse Retention: Research has shown nurses at all licensure levels (LVN, RN, and APRN) have reported burnout and employers often struggle with retaining nurses.

- Promote and sustain healthy work environments through feedback mechanisms, emphasis on work-life balance, promotion of wellness and mental health, team-building activities, and ensuring adequate staff breaks.
- Deter workplace violence through ongoing training including prevention and de-escalation techniques, zero-tolerance policies, and active involvement from administration and leadership.

Promoting Nursing as a Rewarding Career: Nursing has had many "faces" in the media in the past decade. Much of the public may have an idea of what nurses do, but many do not fully comprehend what the job entails, the different types of nursing roles, and the variety of career opportunities for nurses

- Engage nurses in Texas in a campaign promoting nursing as a career.
- Plan or expand recognition programs in schools, clinical facilities, and institutions featuring a *Nurse of the Month* based on exceptional practice.

Nursing Faculty Loan Repayment Assistance Program

Texas is just one of many states in the nation where nurse faculty shortages continue to directly affect the number of students nursing programs are able to enroll. However, attracting more nurses into academic roles as faculty is often difficult due to the cost of higher education. One way to offset the financial burden that many nurse faculty incur when deciding to go back to school is by participating in the Nursing Faculty Loan Repayment Assistance Program (NFLRAP) offered by the Texas Higher Education Coordinating Board (THECB).

The NFLRAP originated as a way to improve access to nursing education programs by encouraging qualified nurses to serve as faculty at eligible institutions of higher education in positions that require an advanced degree in professional nursing.

Eligibility Requirements

To be eligible to receive loan repayment assistance an applicant must:

- hold a master's or doctoral degree in nursing;
- (2) be licensed by the Texas Board of Nursing for the State of Texas;
- (3) apply to THECB by the published application deadline- Spring of 2025; and
- (4) at the time of application for repayment assistance, have been employed part-time or full-time for at least one service period during the last year, and be currently employed part-time or full time as a faculty member of a nursing program at an eligible

institution in a position that requires an advanced degree in professional nursing.

Award Amount

Historically, nursing faculty may receive up to \$7,000 per service period, though recent changes in the program allow THECB to increase this amount if funding allows. A nursing faculty member may receive loan repayment assistance under this subchapter for a maximum of five service periods.

Frequently Asked Questions and Answers

What is considered an eligible institution?

An eligible Institution is any Texas, public, private, or independent institution of higher education, as defined in **§61.003** of the Texas Education Code.

What is considered a service period?

A service period is a period of service equal to a minimum of nine months of a 12-month academic year.

When will I receive the awarded money?

The annual award will be mailed to the lender after each year of service is completed and all required documentation has been received and reviewed.

Practice Question and Answer: Scope of Practice While Working as a Volunteer Emergency Medical Technician (EMT)

Question:

I am a Registered Nurse and I have an opportunity to volunteer at local college games as an EMT (using my EMT license). Are there any restrictions on my scope of practice when I work as a volunteer EMT?

Answer:

The Nursing Practice Act (NPA) and the Texas Board of Nursing (Board) Rules do not preclude a LVN or RN, including a RN/APRN, from seeking employment in unlicensed or technical positions, or in roles the nurse has the knowledge, education, experience, and a valid certificate or license to perform. However, a nurse, who is also licensed by another state agency, is required to comply with the NPA and Board Rules for any acts that are also within the scope of nursing practice [NPA § 301.004(a)(5)].

It's important to know that the Board holds a licensed registered professional nurse, who is working in an unlicensed or technical position, or other role, responsible and accountable to the level of education and competency of a RN. Likewise, a LVN working as an unlicensed or technical person, or in another role, is responsible and accountable to the educational preparation and knowledge of a LVN. This expectation does not apply to individuals formerly licensed as LVNs or RNs or APRNs whose nursing license has been retired, placed on inactive status, surrendered, or revoked.

Current Practice for APRN Licensing/Renewal

Have you gone back to school to obtain a new role and population focus as an Advanced Practice Registered Nursing (APRN)?

- Make sure you apply for this additional license!
- You must be granted the additional licensure title <u>before</u> you can practice in that role/ population focus area.

For Example:

 I am an APRN (Family Nurse Practitioner) with a Texas APRN License who has returned to school to specialize in another area as an APRN (Example, Psychiatric Mental Health Nurse Practitioner). Do I have to apply to the Texas Board of Nursing (BON or Board) for an APRN license since I already have one?

This is a question the BON Staff are asked sometimes. The answer is **yes!** Even if you are already licensed as an APRN in one specialty area or role, once you complete formal graduate nursing education program in another specialty area or role/population, you must apply for licensure in that role prior to being eligible to practice in the new role. Passing the certification does not give you permission to practice without license approval in the new role/population. Once permission to practice in the new role and population is granted by the Board this new role will appear in your Texas Nurse Portal account and through NURSYS.

APRN Licensing Renewals

Are you attempting to complete 400 hours of current practice to obtain or renew your APRN license?

 You must apply for and be issued a 6-month temporary APRN permit <u>before</u> beginning any supervised hours!

This permit requires direct supervision and is not a license to practice.

Here are some examples of who may be required to complete the 400 current practice hours:

Matt just applied for his APRN license, but he completed his APRN Program over two years ago and has never practiced as an APRN. Catherine had an APRN license, but it has been inactive for three years and she wants to reactivate it. Both Matt and Catherine need to complete "current practice" and must obtain a 6-month temporary APRN permit before starting these hours. Since neither has a current APRN license, they cannot practice, even under supervision, until they obtain a 6-month temporary permit. Once the permit is issued, Matt and Catherine can complete APRN practice hours while under the direct supervision of a qualified preceptor.

Accessing TCNWS Data on Nursing Education

The Texas Center for Nursing Workforce Studies (TCNWS or Center), established in 2004, was created in response to mounting concern about Texas' nurse shortage. The passage of House Bill 3126 during the 78th Regular Legislative Session addressed: educating health professionals, the composition and authority of the statewide health coordinating council (SHCC), and certain health planning data collected by the department of health. The Legislature launched the TCNWS to develop an understanding of the nurse shortage and the demographic trends.

The Center is under the governance of the SHCC and was created to collect, analyze, and publish data on the nursing workforce in Texas. TCNWS is part of the Center for Health Statistics at the Department of State Health Services. The Center's team, made up of three researchers, also disseminates data to varied audiences, and provides custom data reports and technical consultations to stakeholders.

The TCNWS publishes data on nurses in Texas regarding:

- Educational and employment trends
- Supply and demand trends
- Nursing workforce demographics
- Migration of nurses

A 21-member nursing advisory committee (NAC) guides the work of the Center. The NAC, comprised of nurses, nurse educators, and nurse employers, as well as representatives from associations that represent these groups; a representative from the Texas Board of Nursing (Board); two nurse researchers; and a consumer member; guides the work of the Center.

The NAC is required by statute to review policy matters on the collection of data and reports produced by the Center, develop priorities and an operations plan for the Center, and review reports and information prior to dissemination. Further, the NAC oversees subcommittees and taskforces related to the various projects conducted by the Center.

The Mission of the TCNWS: To develop and maintain a statewide system that serves stakeholders by describing and forecasting the supply and demand of the changing nursing workforce in Texas. The Vision of the TCNWS: Quality healthcare for all Texans through an optimal nursing workforce based on reliable, valid, and useful data.

The Board's Education Team collaborates with the TCNWS staff to develop and distribute the Nursing Education Program Information Survey (NEPIS) each October. These sets of questions are sent to all vocational, professional, and graduate-level nursing education programs in Texas. Board Rules 214.6/215.6 mandate that the dean/director/coordinator of all Board approved nursing education programs must complete and submit the surveys by the required deadlines.

Factsheets of NEPIS outcomes, published each Spring, are available on the TCNWS website and go back as far as 2007. These reports are accessible from the Board website, www.bon.texas.gov, by selecting the *Education* heading, then *Texas Center for Nursing Workforce Studies*.

NEPIS reports serve as an official source for nursing education data, including: program admissions, enrollment, and graduation numbers; faculty numbers and demographics; student demographics; and program characteristics. Other topics include Nursing Education for High School Students, Update

on Post-Licensure RN to BSN Programs, and Update on Faculty Positions and Demographics in Texas Nursing Programs.

Faculty demographic reports describe:

- Faculty Positions
- Vacancy and Turnover
- Barriers to Recruitment
- Gender
- Age
- Race/Ethnicity
- Educational Preparation

Student demographic reports present:

- Gender
- Age
- Race/Ethnicity

The reports on Nursing Education Program Characteristics include:

- Geographic location
- Changes in the number of programs
- Institution types
- Curriculum length
- Online availability
- Curriculum and program hours (didactic and clinical)

The Board's Education Consultants rely on these data points to prepare for survey visits, develop quarterly Board reports, and track program operations. All data collected by the TCNWS are accessible to the public. Upon request, the Center's staff will provide custom data tables and reports as well as offer presentations at meetings or conferences on data collected and reported by the TCNWS.

The Center is an active member of the National Forum of State Nursing Workforce Centers and is considered a leader in the United States with their exemplary data collection models.

According to Pamela Lauer, MPH, Program Director at the Center, "The team at the Texas Center for Nursing Workforce Studies strives to provide high-quality and timely data so that stakeholders can put it in action toward growing a strong nursing workforce. By working closely with our partners including the Nursing Advisory Committee, the staff at the Board of Nursing, and all the experts who give us their time and expertise, we make strides toward understanding the needs of nurses, nurse educators, and nurse employers to positively impacting the nursing workforce in Texas and in turn improving the health of Texans."

Using Free Monitoring Resources to Follow Bills During the 89th Legislative Session

In Rule 217.11, the Board of Nursing (BON or Board) sets out its expectations that nurses have a responsibility to know and conform to not only the Nursing Practice Act and Board's Rules, but all rules and regulations that originate as Federal, State, or local laws. On January 14, 2025, the 89th Texas Legislative Session begins. Bill filing in the House of Representatives will continue until March 14th, although the Senate can file bills at any time during the session. The regular session continues through June 2nd. Laws passed by the Legislature can impact nursing practice in a variety of ways.

Laws passed during the Texas Legislative Session can affect the way you obtain your education, your license, or what you may do during your nursing practice. The BON is not a source for information pertaining to the status or progress of bills or political issues associated with legislation. Several websites provide information concerning proposed legislation, enacted laws, and agency rules that pertain to nursing practice. Below are some free sites available to you.



Texas Legislature Online

The State of Texas has an informative website for looking at pending or passed legislation. A good place to start your legislative search is the **Texas Legislature Online** (TLO) site. TLO also links to the Texas House of Representatives (House) and Senate. You can enter a word or phrase in the search menu and pull up bills containing those words. You can also go through search matches and check the status, history, or language of those bills. Previous legislative sessions may also be accessed through this site.

Once you have identified bills you are interested in, you can create an account and password with TLO using your email address. After creating the account, bill tracking lists can be created so bill status notifications from TLO can be received.

For example, if you are interested in school nurse related bills, create a new bill list titled School Nurse. Add the bill you found relating to school nurses to the School Nurse list, then set up the types of alerts you wish to receive. After clicking on **Receive Bill and Meeting Alerts** in TLO, enter your bill number and the type of alert you would like to receive. Be aware that if you set the alert to **Any Category**, you will receive emails any time the status of the bill changes.

If or when the bill is scheduled for a hearing in the house where it originates, a notification will be sent by email with the date, time, and location of the hearing. You can monitor the hearing on your computer through the **House** and **Senate** websites on the day of hearing or afterward.

To view archived broadcasts of committee hearing, visit the **House** and **Senate** websites. As the session progresses and bills advance through committee meetings, additional documents are added to TLO. These documents clarify what is proposed in the bill as well as the cost for implementing the bill. Keep in mind that most bills introduced during the session do not make it through both houses and then to the Governor's Office.



Texas Register

The Board of Nursing Bulletin often mentions the **Texas Register** as the publication where nurses can read about proposed rule changes or new rules that have been adopted by state agencies. The *Texas Register* is posted on a weekly basis by the Office of the Secretary of State. If the agency is required to make rule changes to carry out changes from a new bill, proposed rule changes will appear for public comments.

Federal Legislation

One of the best resources for checking on legislation in the U.S. House of Representatives or U.S. Senate is **Congress.gov**

You can enter a word or phrase in the search window for a list of bills containing those key words or go straight to a specific House or Senate bill. You can also read the full text of the bill to see its relevance to your practice or check the bill's status within the legislative process

Other Web Resources

Professional organizations are very active during the legislative session monitoring, responding, and proposing legislation. They frequently have websites that offer updates on legislation affecting nursing.

A nurse with a substance use or mental health condition that might impact nursing practice is encouraged to self-refer to TPAPN prior to the condition impacting nursing practice. Any person may refer a nurse to TPAPN if the condition has not impacted nursing practice; however, persons mandated to report to the Board of Nursing (BON or Board), such as an employer, a nurse, or a nursing peer review committee, are required to report the nurse to the BON if they believe there has been a nursing practice violation.

The TPAPN referral form is on the TPAPN website. The Board website contains links to file a complaint online under Discipline & Complaints – How to File a Complaint.
